**Regular Meeting Minutes**

Regular meeting of the Markey Township Board was conducted in person and by Zoom and was called to order at 7:00 p.m. with the Pledge of Allegiance. **Motion** by Pray, seconded by Donaldson to approve consent agenda to include minutes of regular meeting of May 10, 2021 and special meeting of June 1, 2021, Treasurer's report and bills to include MTA annual dues \$2,432.57. All in favor. MC.

Discussed putting the garbage contract out for bids. Republic Services' contract ends 12/31/21.

Motion by Tussey, seconded by Bell that we purchase online learning subscription from MTA at a cost of \$1,000. All in favor. MC.
